Application recommendations: Spraygro Smartrace Spraytrace 10 is suitable for the following crops when trace element deficiency exists. Apply with sufficient water for thorough coverage of leaves. The rates are to be adjusted according to the tissue and/or soil analysis results.

**BROADACRE:** Rate of application per min water/hectare: 50 litres LUCERNE @ 3-5 litres/hectare. Apply prior to irrigation cycle immediately after first cut.

CITRUS @ 5-6 litres/hectare. Apply 2 applications at bud burst 7-14 days apart. Apply at fruit set and filling.

Apply at regular intervals from bud burst. **VINES** @ 2-4 litres/hectare.

Apply multiple applications of at least 2 weeks apart. TREE CROPS @ 3-4 litres/hectare. @ 3-5 litres/hectare. Apply pre-bloom to post-bloom as required. ALMONDS
